### *Review Report On Statement Of Liquid Capital Balance*

#### Introduction

We have reviewed the accompanying Statement of Liquid Capital Balance of Progressive Investment Management (Pvt.) Limited as at December 31, 2023 and notes to the Statement of Liquid Capital Balance (here-in-after referred to as the 'the statement'). A review of historical financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with the International Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

#### Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the accompanying statement is not prepared, in all material respects, in accordance with the requirements of Third Schedule of the Regulations.
